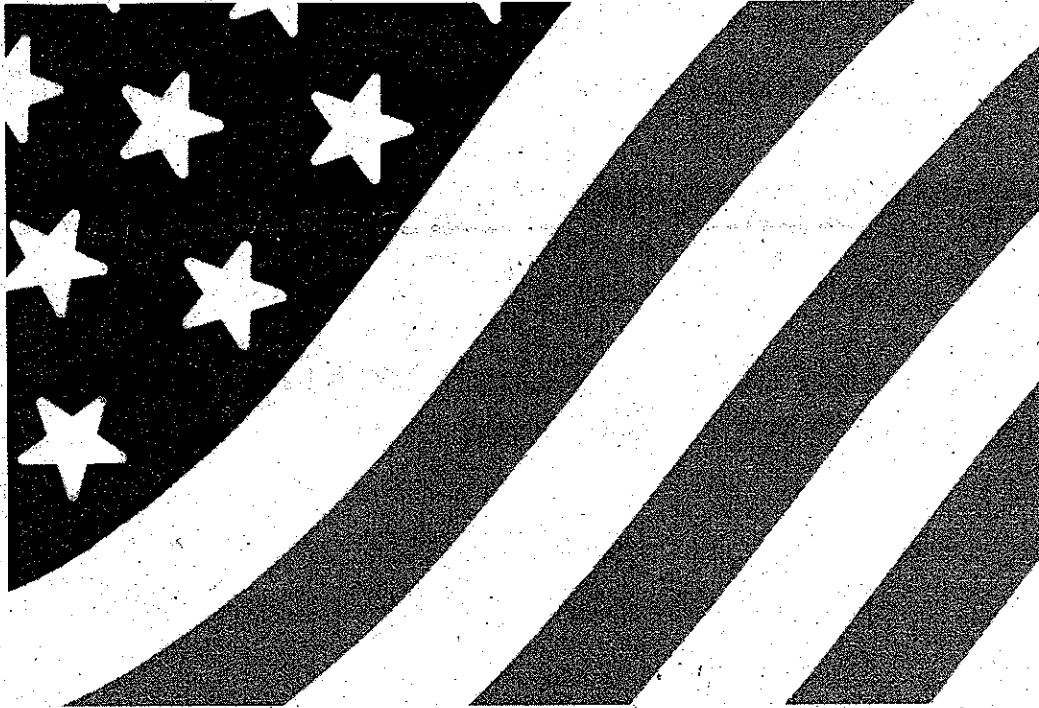

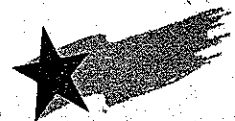

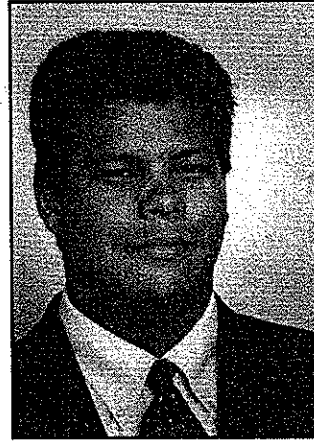

I support a gradual buffer zone around the Urban Growth Boundary to ease development, prevent urban sprawl, and keep homes more affordable.

Taxes

The recent property tax limitation measures haven't provided relief to all residents. In fact, many have seen increases. I see no reason to increase any taxes for the residents of our county. An effectively managed county should have no problems allocating tax dollars to Education, Recycling, Growth Management, Sewage Overflow, and programs you consider important.
