The following people were present for the resolution of tie race:



- Two playing cards were drawn from a new deck of cards
- The playing cards were assigned to each candidate as follows:
 - o Ace of Hearts – Cheryl Lawwill
 - o Ace of Clubs – Todd Mickalson
- The cards were dropped into a hat and shaken by Eric Sample
- The hat was held above eye level by Paula Johnson
- Tim Scott reached up into the hat and drew one card from the hat
- The card was the Ace of Clubs representing Todd Mickalson
- Todd Mickalson was declared the winner in the Corbett School District, Director, Position 4 race








