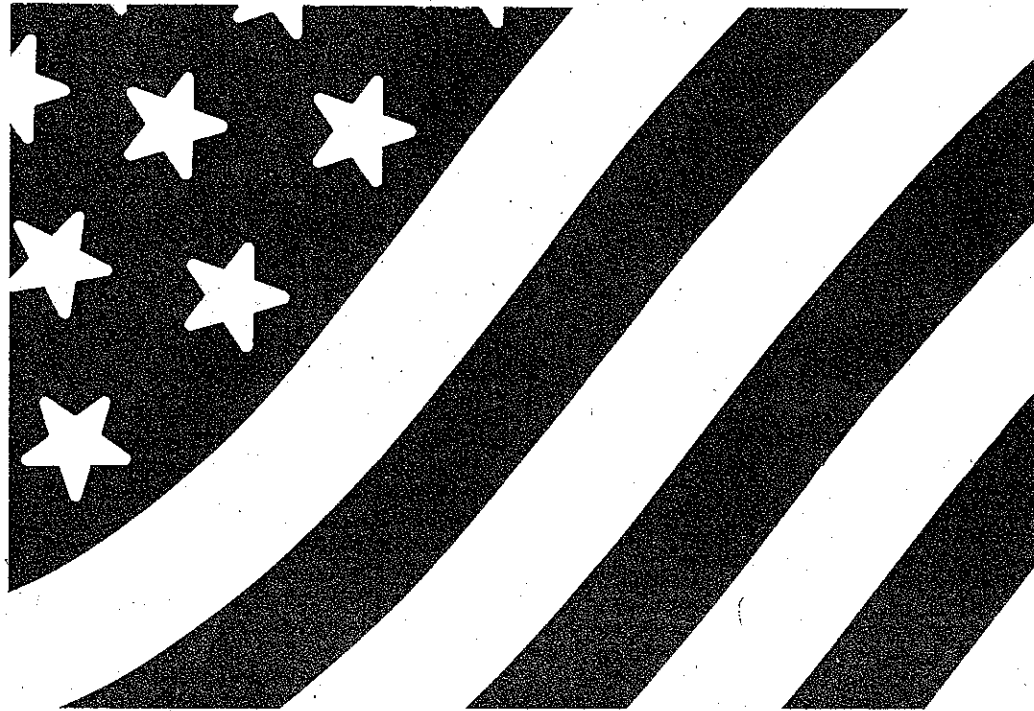

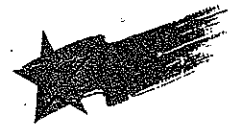

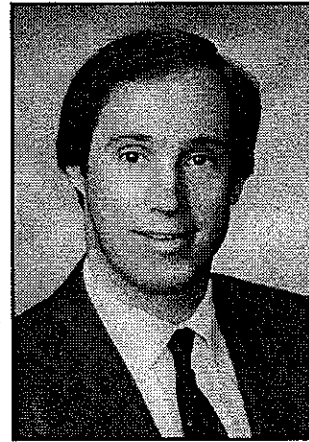

- Negotiated contracts with two micro-electronics companies that will provide up to 2,500 new family wage, career tracked jobs with full benefits.

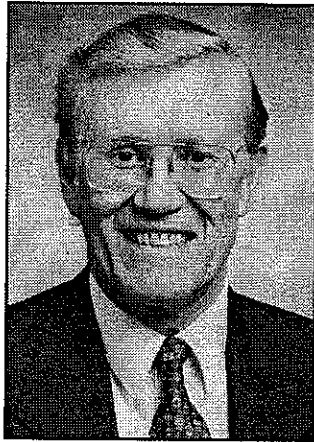

As your County Commissioner, I have worked hard to represent your values and concerns. The primary values that you and I share—fiscal conservatism, reducing crime, stable family-wage employment, and citizen participation in government—must remain a priority for Multnomah County for the next four years.

I successfully opposed the county payroll tax, the county income tax, the utility tax, and the effort to increase taxes on business incomes. Recently, the County imposed competitive bidding on the ambulance industry, lowering ambulance bills by over 20 percent and improving the ambulance response times east of the Sandy River.

To improve public safety, I have supported increasing the size of our criminal detention facilities and improving the substance abuse and mental health treatment that local offenders receive. Multnomah County is working with public schools to expand anti-violence programming for youth. I also led the effort to expand conflict resolution, mediation, and weapons detection in public schools.

I will also be assisting in the implementation of a one-stop career center, for residents of all ages who need workforce assistance.

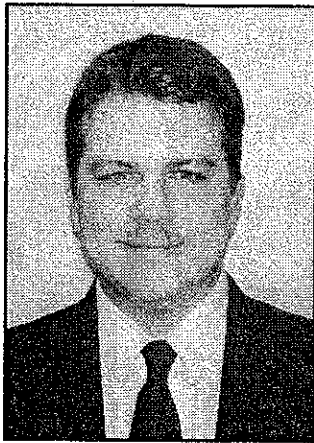

This region faces an arduous task in controlling its growth while maintaining our livability. This is Ed's number one priority.

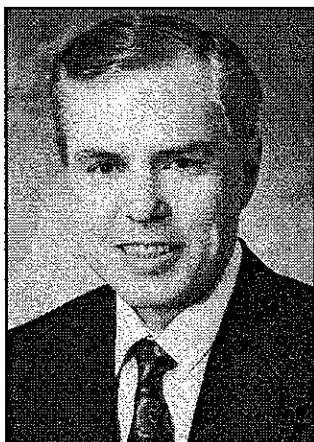
