Attached is a copy of Directive 2012-1 for the 2012 Primary Election. Please review this Directive carefully. Please use the attached ballot statements to proof ballots. Thoroughly review the statements to ensure you include on your ballot all offices that apply to your county and that they are in the correct order.

For your information we provide the following list of <u>state</u> candidates that have been automatically nominated to the 2012 General Election ballot and will not appear on the ballot as required by ORS 249.091.

(ORS 246.110 & 120). The information provided here is an official directive of the Secretary of State.

This directive incorporates the attached instructions for processing the official Ballot Statements issued for the 2012 Primary Election.

The instructions provide information regarding:

- Ballot Label Style
- Color of Ballots
- · Ballot Arrangement for Full Ballot
- Numbering System for Candidates and Measures
- Printing Candidate Names
- · Lines for Candidate Write-In Votes
- Random Ordering of Candidate Names
- Judicial Candidates "Incumbent" Designation
- County Nonpartisan Candidates
- County Judge Candidates

The provisions of ORS 254.108, 254.115, 254.125, 254.145, 254.155 and ORS 260.675 should be reviewed prior to preparing the official ballot.

Enclosed you will find the following Official Ballot Statements. We have also enclosed a list of open offices for the 2012 Primary Election. Study this list to ensure you have every office on your ballot that applies to your county. The state ballot statements consist of:

- 1. Democratic Candidates
- 2. Republican Candidates
- 3. Republican Candidates for the office of Secretary of State, Attorney General and State Treasurer requested by Nonaffiliated Voters.
- 4. Nonpartisan Candidates Judiciary and District Attorney

These Statements will serve as a guide in preparing your county's ballot.

The Secretary of State directs the following:

BALLOT LABEL STYLE

The official Primary Election Ballot shall be styled using:

- 1) "Official Primary Nominating Ballot for the Democratic Party"
- 2) "Official Primary Nominating Ballot for the Republican Party"
- 3) "Official Primary Nonpartisan Ballot"
- 4) "Official Nonaffiliated Ballot including Republican Party Primary Nominating Contests."

See ORS 254.115 for further requirements.

COLOR OF BALLOTS

All official Primary Election ballots shall be printed in black ink on good quality material. The following color system for the Official Primary Ballots has been designated, pursuant to ORS .254.195(1):

- 1. Democratic Green
- 2. Republican Yellow
- 3. Nonpartisan White

BALLOT ARRANGEMENT FOR FULL BALLOT

The offices shall be arranged as follows:

- 1. United States President
- 2. United States Representative
- 3. Secretary of State
- 4. State Treasurer
- 5. Attorney General
- 6. State Senate
- 7. State Representative
- 8. County if partisan
- 9. City if partisan
- 10. Precinct committee person
- 11. Nonpartisan the sequences for all nonpartisan offices shall be as follows:
 - a. State judicial offices of Supreme Court, Court of Appeals, Judge of the Oregon Tax Court and Circuit Court, in the sequence shown on the enclosed ballot statement. These offices are listed in the following order:
 - i. Contested Supreme Court, Pos. 3;
 - ii. Uncontested Supreme Court, positions 2 and 6;
 - iii. Contested Court of Appeals, Pos. 6;
 - iv. Uncontested Court of Appeals positions 5, 8, 9 and 10;
 - v. Contested Circuit Court positions; and
 - vi. Uncontested Circuit Court positions.
 - b. District Attorney
 - c. County Judge
 - d. Nonpartisan County Candidates (such as County Clerk, County Assessor, County Surveyor, County Treasurer, Sheriff and Justice of the Peace)
 - e. Nonpartisan City Candidates
 - f. Special District Candidates if any
- 12. Measures
 - a. County
 - b. City
 - c. Multi-County Special District
 - d. Single County Special District

If for any reason you feel that the ballot arrangement as set forth will cause you undue administrative or printing problems, please contact this office for further advice.

NUMBERING SYSTEM

- 1. Candidates Automated Tally Systems: Unique candidate numbers are not required.
- 2. <u>Measures:</u> The number assigned to each local (county, city and district) measure must be preceded by a unique county prefix number (*i.e.*, Baker County is number 1, Benton is number 2, and so forth, numbered consecutively in alphabetical order until Yamhill County, which is number 36).

If a district or city is located in more than one county, the county elections officer who is the filing officer shall immediately certify the district or city measure and number to the county clerk of any other county in which the district or city is located. The same measure number shall be used in all counties in which the election is conducted for that measure.

CANDIDATE NAMES

The names of candidates shall be printed on the official ballot as indicated on the Ballot Statement. The names of candidates should be in **bold face and mixed case type**, as shown on the attached statements. We direct you to continue to have **bold face type** and for the purpose of better readability, you **must use mixed case type rather** than all upper case type for candidate and political party names. Mixed case means the first letters of these names shall be upper case with the rest lower case (unless within the name an upper case letter is specified by the candidate, such as McVan), as is included in the candidate ballot statement attached.

ORS 249.031 allows for a candidate to use a nickname in parentheses. ORS 254.145(1) provides that no title or designation may be included in the candidate's name (such as Dr., Mr., PhD, Senior Vice President, etc.). However, it is allowable to include a designation such as Jr., Sr., III, IV, etc. if it is actually part of the name by which the candidate is commonly known.

Note: If no candidate has filed for an office, the ballot must include "No Candidate Filed."

LINES FOR CANDIDATE WRITE-IN VOTES

Provide for the write-in of names in the appropriate place for the ballot style, in accordance with ORS 254.145. Allow one blank line for each position to be filled. Example: "Vote for Three." In this case, you will provide three blank lines following the list of candidates for that office. Blank lines shall not be numbered. Voting squares need not be printed on blank lines.

Offices that have been certified as "No Candidate Filed" must still appear on the ballot with the appropriate number of write-in lines. "No Candidate Filed" may be shown on what would have been the candidate name line.

RANDOM ORDERING OF CANDIDATE NAMES

The names of the candidates shall be ordered as provided for in ORS 254.155. On March 8, 2012, this office sent a memo to all County Election Officials giving the random ordering of the letters of the alphabet for candidates on the ballot for the May 20, 2008 Primary Election. An additional copy of that memo is attached to this directive. The ballot statements for state candidates prepared by the Secretary of State are listed using the random sequence.

The random ordering of the letters of the alphabet for which candidate's names will be placed on the ballot for the May 15, 2012, Primary Election is as follows:

For candidates whose last names begin with the same letter(s) of the alphabet, or whose names are identical etc., follow the procedure contained in OAR 165-010-0090. A copy of that rule is attached to this directive.

ORS 254.115(4) requires if two or more candidates for the same office have the same or similar surnames, the location of their places of residence shall be printed opposite their names to distinguish one from another.

JUDICIAL CANDIDATES "INCUMBENT" DESIGNATION

The information for state candidates for Supreme Court, Court of Appeals, Judge of the Oregon Tax Court and Circuit Court positions shall include a designation of "Incumbent" for each candidate who is the regularly elected or appointed judge of the court to which the candidate seeks election. ORS 254.125. The ballot statements provide this designation.

Please note that district attorney, justice of the peace, county judges and municipal court candidates do not have the "incumbent" designation.

COUNTY NONPARTISAN CANDIDATES

ORS 249.091 provides if <u>one</u> or <u>two</u> candidates have filed for the offices of Sheriff, County Treasurer or County Clerk or to fill a vacancy in a nonpartisan office, the candidates shall be the nominees for the office at the general election only. The names of the candidates will not be on the primary election ballot.

If <u>three or more</u> candidates file for County Clerk, Treasurer, Sheriff or a nonpartisan office to fill a vacancy, the contest will be on the primary ballot. The nominee is not elected at the primary election. If no candidate receives a majority of the votes, the top two vote getters move forward to the general election.

If the nonpartisan office would regularly be filled by election during this election year, ORS 249.088 applies. Under ORS 249.088 a nonpartisan candidate (except those described above) can be elected at the primary election if the candidates receive a majority of the votes cast (50% plus one vote).

COUNTY JUDGE CANDIDATES

There are four County Judge positions on the 2012 Primary Election. We note that the office of County Judge (those who exercise judicial functions, but <u>not</u> Justice of the Peace positions) are classified as nonpartisan, and are included as a "state office."

Therefore, when there are any up for election, those offices appear on the ballot after District Attorney but <u>before</u> other county offices.
