FY 2023 Gun Violence Investments - \$1.27 million


- General Fund \$450,000
 - 2 full time equivalent (FTE) prosecutors
- American Rescue Plan (ARP) \$821,802*
 - 2 limited duration prosecutors
 - 2 limited duration investigators

*Continues FY 2022 mid-year investment of \$1.05 million ARP funds (4 limited duration prosecutors & 2 limited duration investigators); in FY 2023, 2 of the 4 prosecutors were made permanent through use of ongoing General Fund.



Initial Homicide Findings

2022 Homicides: DDA Call Outs

January 1, 2019 through August 30, 2022

- The number of homicide call outs have increased 187% from 2019 to 2021
- The number of *call outs for shooting homicides has increased 196%* from 2019 to 2021.
