Mike Sellinger and MaryJo provided a presentation available in Dropbox followed by an opportunity for questions and comments.

The following highlights were provided by Alta:

Mike Sellinger and Katie Mangle from Alta Planning + Design will prepare the Safety Action Plan with EMCTC. The outcome of the project will be a plan that makes the County eligible to apply for implementation funding.

Our approach to the project will be to

Lead with listening: Center the people behind the data.

Focus on connecting with people of color, people who walk, bike, and ride transit, and community members with lower incomes.

Leverage regional analysis to dive deeper into local issues and solutions

Build a culture of safety

Prepare for implementation

Key Project Components:

The project will last until approximately October 2025, in time to apply for the next round of funding. We will begin with analysis of existing conditions and goal setting, and build from that to identify solutions that would work for this particular place. Throughout the project we will speak with and listen to the communities, and engage with the many agencies involved.

We think of the project as having three phases: Listen and Learn, Share, and Refine. The project will begin by talking with people about their experiences, not just asking them to review data and maps. Our intent will be to

verify and humanize data trends with public perceptions and experiences. We will invest in and rely on relationships with partner organizations.

The engagement with affected and involved agencies will follow the same phases, but the questions we ask will be different. The agencies (EMCTC) will approve the Public Engagement Plan before we begin. What we hear from the public will inform the goal setting we do with EMCTC.

Safety Action Plans are data-driven plans. Metro is already doing a lot of work on this, so we will leverage the regional analysis to dive deeper into local issues and solutions. Supplement the High Injury Corridors, and analyze locations where there are crashes and the severity of the crashes, as well as contributing factors and crash types by relevant road users. To provide an enhanced view of equity, Alta will conduct an equity analysis using a data-driven approach that prioritizes network segments with higher rates of trip taken by disadvantaged or vulnerable populations based on the Replica Places Platform.

- regulation of electric bikes
- a few different funding requests (Bridge of the Gods)
- Regionally related bills including federal review of several routes (30, 101)
- Cost allocation - who's paying - cars or freight vehicles Study that is out
- Utilities - allowing jurisdictions to recoup the cost for permits in ROW
- Crime of using drugs on public transit

- Install cameras on bus stop arms

Urban Flood Safety discussion and 2025 transportation funding package - will focus on back-to-basics such as funding for maintenance and operations
