Department of Community Justice

Provides supervision and treatment to youth, adults, families, and communities. Programs include Adult Services, Juvenile Services, Crime Victims Services, and Family Court Services.

Department of Community Services

Programs include Elections Division, Animal Services, Land Use Planning, and Transportation. Maintains county roads and bridges.

Department of County Assets

Manages computer systems and software, buildings and property, mobile devices and telephones, a fleet of vehicles, and archives; also provides budget and finance services.

Department of County Management
