Shall the District impose a \$ .60 per \$1,000 of assessed value for operating expenses beginning in 2012-2013? This measure may cause property taxes to increase more than three percent.

**Summary** 175 words

The taxes will be used to meet operating expenses of the Alto Park Water District and to maintain a contingency fund for future operating expenses. The primary operating expense is a contract for fire protection services with the Lake Oswego Fire Department. The tax is estimated to raise the following amounts: \$13,599 in 2012-2013; \$14,007 in 2013-2014; \$14,427 in 2014-2015; \$14,860 in 2015-2016; and \$15,306 in 2016-2017. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate.
