- **ADVS Report – Lee Girard**

Evidence-based Health Promotion

- FY 15 one-time-only (OTO) \$201,129 (for one year)
- FY 15/17 biennium - \$197,310 - \$98,655/yr
- State requires a plan - strongly urging ADVSD to fund a program coordinator (at 0.5 FTE)
- Remaining funds - approximately \$44,000 to direct services

OPI -

- FY 13/15 - initial \$2,912,678, with additional OTO \$3,321,328
- FY 15/17 - \$2,935,909
- Setting limits on in-home services hours (cap of 20 hrs/month) and eliminating newer services such as chore and assistive tech/special medical needs
- Many other areas in Oregon has established waiting lists

Sequestration Mitigation

- \$145,000/yr
- Hiring 1.0 FTE Program Specialist to oversee program & contract administration
- \$23,255 in direct client assistance for family caregivers
- \$62,000 for enhancing equity services

Medicaid

- Able to hire 6 Case Manager 2 positions and 1 Case Management Assistant - will reduce LTC service caseloads
