ORDER NO. 2020-030

Legalization of a Portion of SE Foster Road, as County Road No. 5030.

The Multnomah County Board of Commissioners Finds:

- a. SE Foster Road was established as County Road No. 81 in 1874 and the location of the road cannot be accurately determined due to numerous alterations of the road, a defective survey of the road and adjacent property, and the road as traveled and used for at least the past 10 years at this location, between the easterly boundary of the City of Portland and the South boundary of Multnomah County, does not conform to the existing records for this county road.
- b. SE Foster Road has been traveled and used by the public and maintained by the County for more than 25 years.
- c. On February 7, 2019, consistent with ORS 368.201 to 368.221, the Board of Commissioners adopted Resolution No. 2019-014 initiating proceedings for legalizing a portion of SE Foster Road and directed the County Surveyor to conduct a survey of the road in its traveled location.
- d. On March 19, 2020, the County Surveyor filed his survey with the Board Clerk and the County Engineer filed a report supporting legalization of SE Foster Road. Subsequently, on March 19, 2020, the Board adopted Resolution No. 2020-018 Scheduling a Public Hearing and Directing Notice Thereof for the Legalization of a Portion of SE Foster Road, County Road No. 81.
- e. County Transportation has provided notice of this May 14, 2020 proceeding in compliance with ORS 368.206(1)(c).
- f. The Board has determined that the legalization of the Road is in the public interest.

The Multnomah County Board of Commissioners Orders:

1. As authorized under ORS 368.201 to 368.221, that the portion of SE Foster Road, County Road No. 81, located in unincorporated Multnomah County, Oregon as more particularly described in the attached Exhibit A ("the Road"), is hereby legalized as a county road, specifically to be known as County Road No. 5030.
2. Further, as provided by ORS 368.216(2), the County Surveyor and County Transportation staff shall comply with all of the requirements of ORS 368.106(1)-(4), to perfect the legalization of the Road.

3. Upon the completion of the legalization procedures required under ORS 368.201 to 368.221, any records showing the location of the Road that conflict with the location of the Road as described in this Order are void, and the Road exists as shown on this Order.



EXHIBIT "A"
FOSTER ROAD
COUNTY ROAD NO. 5030

A strip of land located in the Southeast One-Quarter, Southwest One-Quarter, and the Northwest One-Quarter of Section 19, Township 1 South, Range 3 East of the Willamette Meridian, Multnomah County, Oregon, said strip of land being 60 feet in width, 30 feet on each side of the following described Centerline:

Beginning at Engineer's Station 0+00, said Station being on the south line of said Section 19 from which a 4" brass disk in a monument box found at the Southeast Corner of said Section 19 bears N 89°29'29"E, 1159.26 feet, said south line being the south boundary of Multnomah County;

Thence N5°39'47"W, 507.24 feet to Engineer's Station 5+07.24 PC and the beginning of a 573.69 foot radius curve to the left having a central angle of 19°55'41";

Thence along the arc of said curve to the left (the long chord of which bears N15°37'37"W, 198.53') 199.53 feet to Engineer's Station 7+06.77 PT;

Thence N25°35'28"W, 685.75 feet to Engineer's Station 13+92.52 PC and the beginning of a 383.06 foot radius curve to the left having a central angle of 34°22'59";

Thence along the arc of said curve to the left (the long chord of which bears N42°46'57"W, 226.44') 229.87 feet to Engineer's Station 16+22.39 PT;

Thence N59°58'27"W, 1001.42 feet to Engineer's Station 26+23.81 PC and the beginning of a 1146.28 foot radius curve to the right having a central angle of 16°49'03";

Thence along the arc of said curve to the right (the long chord of which bears N51°33'55"W, 335.25') 336.46 feet to Engineer's Station 29+60.27 PT;

Thence N43°09'24"W, 747.00 feet to Engineer's Station 37+07.27 PC and the beginning of a 2864.93 foot radius curve to the left having a central angle of 6°33'00";

Thence along the arc of said curve to the left (the long chord of which bears N46°25'54"W, 327.34') 327.52 feet to Engineer's Station 40+34.79 PT;

Thence N49°42'24"W, 1080.08 feet to Engineer's Station 51+14.87 PC and the beginning of a 287.94 foot radius curve to the right having a central angle of 36°04'20";

Thence along the arc of said curve to the right (the long chord of which bears N31°40'14"W, 178.30') 181.28 feet to Engineer's Station 52+96.15 PT;

Thence N13°38'04"W, 620.01 feet to Engineer's Station 59+16.16 PC and the beginning of a 287.94 foot radius curve to the left having a central angle of 4°00'49";

Thence along the arc of said curve to the left (the long chord of which bears N15°38'28"W, 20.17') 20.17 feet to the boundary of the City of Portland, Multnomah County, Oregon and the **Terminus Point** of said

Centerline from which a 1/2" iron pipe bears S41°50'19"W, 35.56 feet and a 5/8" iron rod with a yellow plastic cap inscribed "MULT. CO. SURVEY" bears S70°21'22"E, 36.73 feet.

The side lines of said strip of land are to be lengthened or shortened to terminate on the south by the south line of said Section 19 and on the north by said boundary of the City of Portland.

This legal description along with the basis of bearings thereof was established based on that Survey recorded as Survey Number 67098, Multnomah County Survey Records.

NARRATIVE

PURPOSE

THE PURPOSE OF THIS SURVEY IS TO LOCATE THE CENTERLINE AND RIGHT OF WAY LINES OF THAT PORTION OF SE FOSTER ROAD LYING WITHIN UNINCORPORATED MULTNOMAH COUNTY (FROM THE SOUTH BOUNDARY OF MULTNOMAH COUNTY TO THE EASTERLY BOUNDARY OF THE CITY OF PORTLAND) FOR A 60.00 FOOT ROAD LEGALIZATION UNDER ORS 368.201 TO 368.221. THIS SURVEY WILL ALSO LOCATE AND MONUMENT THE ADDITIONAL RIGHT OF WAY DEDICATIONS ALONG THE ALIGNMENT.

ROAD HISTORY

SE FOSTER ROAD WAS ESTABLISHED DECEMBER 18, 1874 AS COUNTY ROAD NO. 81. NO WIDTH WAS STATED IN THE ESTABLISHMENT RECORD. THE STATUTORY WIDTH FOR A COUNTY ROAD AT THE TIME OF ESTABLISHMENT WAS 60.00 FEET. JUNE 11, 1880 COUNTY ROAD NO. 116 RELOCATED A PORTION OF SAID SE FOSTER ROAD. NEITHER ALIGNMENT INCLUDED CURVES. IN APRIL OF 1934, A FIELD SURVEY OF THE ROAD (ROAD MAP F 13/2) WAS COMPLETED BY THE MULTNOMAH COUNTY HIGHWAY DEPARTMENT BETWEEN THE CITY OF PORTLAND BOUNDARY AND THE COUNTY LINE. THIS SURVEY INTRODUCED CURVES INTO THE ALIGNMENT AND APPEARS TO FOLLOW THE ALIGNMENT OF THE ROAD AS IT EXISTED AT THE TIME AND AS IT LARGELY EXISTS TODAY. IT APPEARS THAT NO OFFICIAL ACTION WAS TAKEN BY MULTNOMAH COUNTY TO ESTABLISH THIS ALIGNMENT.

FROM 1934 TO THE PRESENT DATE ALL SURVEYS AND ADDITIONAL RIGHT OF WAY DEDICATIONS HAVE HELD THE ALIGNMENT AND MONUMENTS SET FROM THE 1934 SURVEY TO LOCATE THE RIGHT OF WAY. THERE ARE NO APPARENT ENCROACHMENTS WITHIN THIS ALIGNMENT WITH THE EXCEPTION OF FENCES. THEREFORE, THE MONUMENTS SET AND RECORD DATA FROM THE 1934 SURVEY WERE HELD IN ESTABLISHING THE ALIGNMENT TO BE LEGALIZED, AS SHOWN ON THIS SURVEY.

BASIS OF BEARING

THE INVERSE FROM CP 42 TO 4" BRASS DISK AT THE SE CORNER OF SECTION 19 WAS HELD TO BE S46°02'31"E AS THE BASIS OF BEARINGS FOR THIS SURVEY BASED ON THE OREGON COORDINATE REFERENCE SYSTEM "PORTLAND ZONE" AS DEFINED IN THE OREGON ADMINISTRATIVE RULES 734-005-0015(3)(dd).

LEGALIZATION CENTERLINE SE FOSTER ROAD

THE CENTERLINE BETWEEN STATION 0+00 AND 5+07.24 WAS LOCATED BY HOLDING THE RECORD ANGLE AND DISTANCE OFF CENTERLINE TO MONUMENT 142 AND MONUMENT 143 AS A 30.00 FOOT OFFSET TO CENTERLINE PER R1. STATION 0+00 WAS LOCATED AT THE INTERSECTION OF SAID CENTERLINE AND THE SOUTH LINE OF SECTION 19.

THE CENTERLINE BETWEEN STATION 7+06.77 AND 13+92.52 WAS LOCATED BY HOLDING MONUMENTS 129 AND 144 AS 30.00 FOOT OFFSETS TO CENTERLINE PER R1.

A TANGENT CURVE WAS THEN FIT BETWEEN STATIONS 5+07.24 AND 7+06.77 HOLDING THE RECORD RADIUS OF 573.69 FEET PER R1.

THE CENTERLINE BETWEEN STATIONS 16+22.39 AND 26+23.81 WAS LOCATED BY HOLDING MONUMENTS 140 AND 107 AS 30.00 FOOT OFFSETS TO CENTERLINE PER R1.

A TANGENT CURVE WAS THEN FIT BETWEEN STATIONS 13+92.52 AND 16+22.39 HOLDING THE RECORD RADIUS OF 383.06 FEET PER R1.

THE CENTERLINE BETWEEN STATIONS 29+60.27 AND 37+07.27 WAS LOCATED BY HOLDING MONUMENTS 102 AND 105 AS 30.00 FOOT OFFSETS TO CENTERLINE PER R1.

A TANGENT CURVE WAS THEN FIT BETWEEN STATIONS 26+23.81 AND 29+60.27 HOLDING THE RECORD RADIUS OF 1146.28 FEET PER R1. STATION 37+07.27 WAS THEN LOCATED AT RECORD DISTANCE OF 747.00 FEET FROM STATION 29+60.27 PER R1.

FROM STATION 37+07.27 A TANGENT CURVE HOLDING RECORD RADIUS OF 2864.93 FEET AND LENGTH OF 327.52 FEET PER R1 WAS HELD TO ESTABLISH STATION 40+34.79.

THE CENTERLINE BETWEEN STATIONS 40+34.79 AND 51+14.87 WAS LOCATED BY HOLDING ESTABLISHED STATION 40+34.79 AND MONUMENT 159 AS A 30.00 FOOT OFFSET TO CENTERLINE AND RECORD DISTANCE OF 1080.08 FEET PER R1 FROM SAID STATION 40+34.79 TO ESTABLISH STATION 51+14.87.

THE CENTERLINE BETWEEN STATIONS 51+14.87 AND 59+16.16 WAS LOCATED BY HOLDING A TANGENT CURVE FROM STATION 51+14.87, HOLDING RECORD RADIUS OF 287.94 FEET PER R1 AND ADJUSTING THE DELTA ANGLE OF SAID CURVE TO CREATE A TANGENT LEAVING SAID CURVE THAT HOLDS MONUMENT 162 AS A 30.00 FOOT OFFSET TO SAID TANGENT.

THE CENTERLINE BETWEEN STATION 59+16.16 PC AND 59+36.33 WAS LOCATED BY HOLDING MONUMENT 162 AS A POINT 30.00 FEET LEFT OF STATION 59+16.16 PC AND THE RECORD RADIUS OF 287.94 FEET PER R1. STATION 59+36.33 WAS LOCATED BY HOLDING THE RECORD CURVE DATA FROM SN 61957 ALONG THE WESTERLY RIGHT OF WAY LINE FROM MONUMENT 162 AND THE RECORD ANGLE OFF OF A RADIAL LINE AT THE END OF SAID CURVE TO LOCATE THE SOUTHERLY LINE OF SAID SURVEY WHICH WAS EXTENDED TO INTERSECT WITH SAID CENTERLINE. THE SOUTHERLY LINE WAS ALSO HELD TO LOCATE THE CITY OF PORTLAND BOUNDARY WESTERLY OF THE CENTERLINE. THE CITY OF PORTLAND BOUNDARY ON THE EASTERLY SIDE OF SAID CENTERLINE WAS LOCATED BY HOLDING THE RECORD DISTANCE SOUTHERLY OF MONUMENT 161 AND THE RECORD ANGLE OFF OF THE EASTERLY RIGHT OF WAY LINE PER SN 39486.

SE CHELDELIN ROAD (COUNTY ROAD NO. 1094)

MONUMENTS 30 AND 1004 WERE HELD TO LOCATE THE CENTERLINE OF SE CHELDELIN ROAD, THE SOUTH LINE OF SECTION 19, AND THE SOUTH LINE OF MULTNOMAH COUNTY. THE CENTERLINE WAS THEN OFFSET 20.00 FEET NORTH AND SOUTH TO LOCATE THE RIGHT OF WAY LINE LINES PER THE FIELD NOTES FOR SAID ROAD NO. 1094.

SE RICHEY ROAD (COUNTY ROAD NO. 509)

ROAD ANGLE POINT "A" WAS LOCATED HOLDING MONUMENT 127 AS A CENTERLINE ANGLE POINT AND MONUMENT 125 AS A POINT ON THE NORTHERLY RIGHT OF WAY LINE (AS PER SN 64642) AND RECORD FIELD NOTE DISTANCE OF 889 FEET PLUS 1.08 FEET PER R6 FROM SAID MONUMENT 127, PER R6. POINT "B" BEING A POINT ON THE SOUTHERLY RIGHT OF WAY LINE WAS LOCATED 30.00 FEET FROM THE LEGALIZATION CENTERLINE AT THE RECORD CURVE LENGTH OF 120.21' FROM THE RIGHT OF WAY POINT OF CURVATURE, PER SN 17698. THE CENTERLINE SOUTHWESTERLY FROM POINT "A" WAS LOCATED HOLDING POINT "B" AS A 30.00' OFFSET TO CENTERLINE AND EXTENDED WESTERLY TO THE LEGALIZATION CENTERLINE, PER SN 17698. RIGHT OF WAY LINES WERE LOCATED AT THE RECORD DISTANCE OF 30.00' FROM SAID CENTERLINE.

SE 172ND AVENUE (COUNTY ROAD NO. 531)

MONUMENTS 101 AND 109 WERE HELD TO LOCATE THE WESTERLY RIGHT OF WAY LINE OF SE 172ND AVENUE PER PARTITION PLAT NO. 2009-77, MULTNOMAH COUNTY PLAT RECORDS. THE WESTERLY RIGHT OF WAY LINE WAS THEN OFFSET 20.00 FEET TO LOCATE THE CENTERLINE AND 40.00 FEET TO LOCATE THE EASTERLY RIGHT OF WAY LINE.

THE WESTERLY LINE WAS LOCATED AT 40.00' FROM THE LEGALIZATION CENTERLINE, PER SAID DEED. THE SOUTHERLY LINE OF SAID DEED HELD THE SECTION LINE AND THE NORTHERLY LINE OF SAID DEED WAS LOCATED BY HOLDING MONUMENTS 134 AND 135 PER SN 51685.

THE EASTERLY LINE WAS LOCATED AT 45.00' FROM THE LEGALIZATION CENTERLINE, PER SAID DEED. THE SOUTHERLY LINE WAS LOCATED HOLDING THE RECORD ANGLE FROM A LINE RADIAL TO THE CENTERLINE CURVE THROUGH MONUMENT 130, PER SN 28998. THE NORTHERLY LINE WAS LOCATED BY HOLDING THE RECORD ANGLE FROM MONUMENT 121 OFF OF LINE FROM MONUMENT 121 TO MONUMENT 120, PER SN 17698.

THE WESTERLY LINE WAS LOCATED AT 45.00' FROM THE LEGALIZATION CENTERLINE, PER SAID DEEDS. THE SOUTHERLY LINE WAS LOCATED BY HOLDING MONUMENT 128 AND THE RECORD ANGLE OFF THE LEGALIZATION CENTERLINE, PER SN 43111. THE NORTHERLY LINE WAS LOCATED HOLDING RECORD DEED DISTANCES ALONG THE LEGALIZATION CENTERLINE AND THE RECORD ANGLE PER SAID DEED 982-741

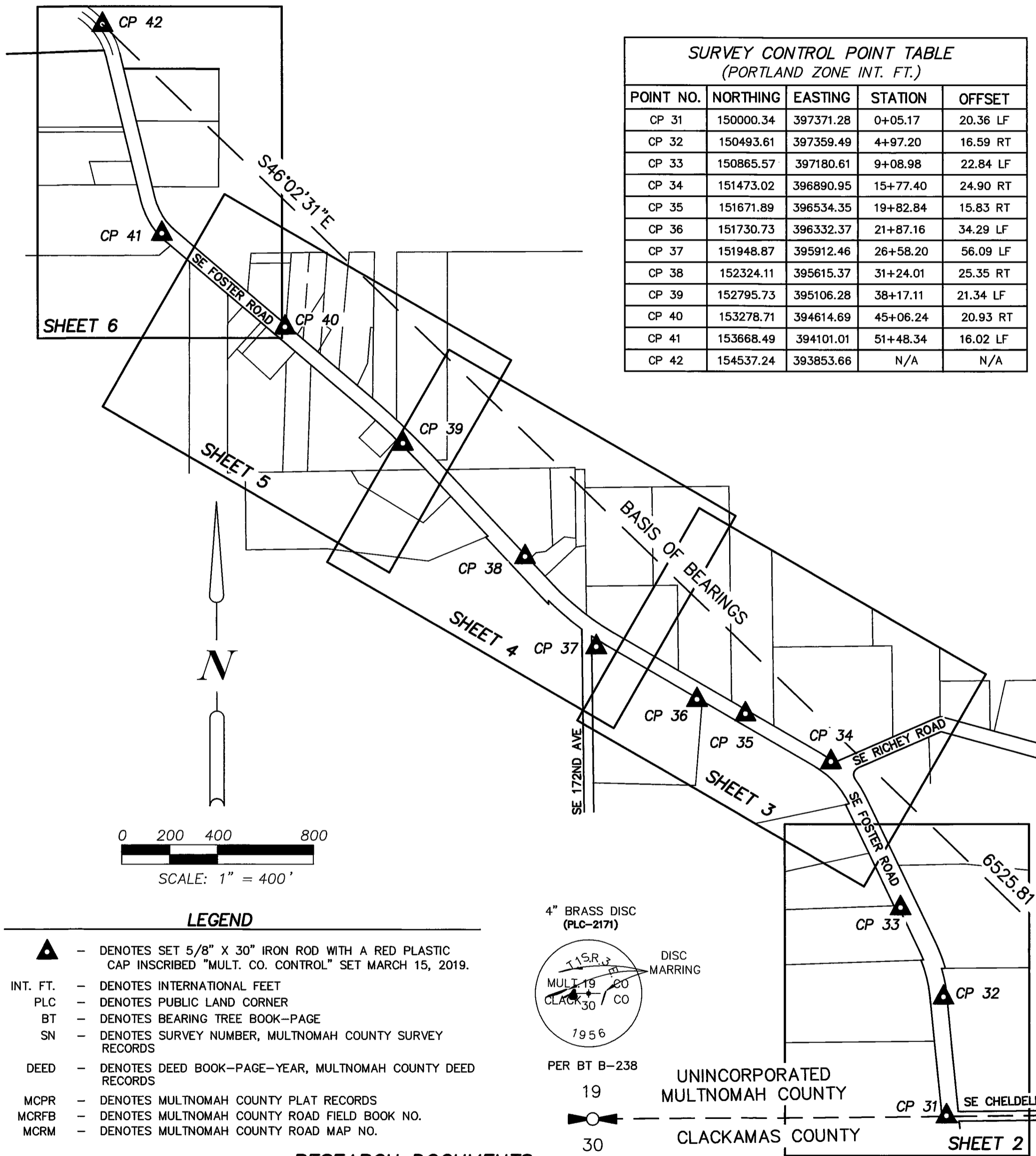

THE SOUTHERLY LINE WAS LOCATED BY HOLDING A LINE FROM MONUMENTS 103 AND 104 AND TERMINATING SAID LINE AT THE 30.00 FOOT AND 40.00 FOOT CENTERLINE OFFSETS. THE NORTHERLY LINE WAS LOCATED BY HOLDING MONUMENT 164 FOR LINE AND THE RECORD ANGLE FROM THE 40.00 FOOT CENTERLINE OFFSET, PER SN 66641.

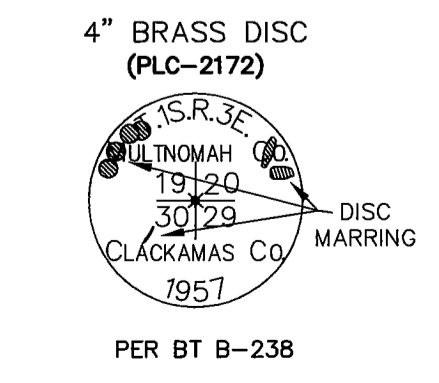
