Climate Justice

In my 10 years in Portland, I have watched elected officials disregard environmental studies, neighborhood associations, activists, and indigenous tribes to everyone’s detriment.

As a city, we must

- implement risk-bonding and **phase out fossil fuels** at the Critical Energy Infrastructure (CEI) Hub,
- **build shade equity** to bolster climate resilience across neighborhoods,
- increase Portland Bureau of Emergency Management’s (PBEM) budget to **prepare for climate disasters**, and
- de-prioritize cars to **fund bike and pedestrian infrastructure**.

Zoning Reform

Zoning laws emerged out of exclusionary policies aimed at stabilizing housing prices, which fuels our housing crisis. We need **affordable housing** such as single-room occupancy units and apartments. We can do this by **lifting zoning restrictions** on new apartment construction and implementing mixed-use zoning to create a more walkable city.

Diverse, Thriving Communities

We must create customizable solutions for our city’s complex dilemmas. To address our housing, addiction, and mental health crises, we need

THE POWER GRID COLLAPSES. Communication systems go silent. Sewers overflow. Nearly 100,000 homes are destroyed. Most of Portland's bridges disintegrate. Looters emerge, capitalizing on the chaos. Tens of thousands of displaced coastal refugees pour into the city, seeking food, water, and shelter. Portland, as we know it, would become unrecognizable...

The Oregon Department of Geology reports that if the megaquake happened tomorrow, Portland could see "more than \$80 billion in building damage, tens of thousands of people wounded or killed, and over 250,000 facing long-term displacement." (*The Oregonian*, 03/15/2018).

But it doesn't have to be this way.

IMAGINE INSTEAD...

CASCADIA READY is the plan to provide green jobs and ensure **everyone** in Portland has an affordable, disaster resistant home.

When the megaquake strikes, decentralized energy grids in every neighborhood keep the lights on, powered by local renewable generators. Managed by a public utility district, rates have long been affordable. Community gardens have proliferated throughout the city, beautifying our streets and providing an emergency food supply for all in need.

We've decommissioned the CEI Hub, which will no longer threaten to pollute our water supply with a deluge of petroleum. City Council's finances are no longer beholden to Wall Street, because our resources are reinvested in the community instead.

A Green Public Bank will invest in worker cooperatives and prevailing wage jobs to rebuild our infrastructure for the dangers posed by the megaquake and climate change alike. A \$25/hour minimum wage will be paired with a cost-of-living adjustment, rent control, and financial support for small businesses to empower workers and revitalize Portland's economy.

Chris Henry will prioritize the immediate needs of working Portlanders now and proactively advance our long-term goals for resilience and survival into the future.






