

- Inform 2028 RTP




Open Now: 30-day Public Comment Period

What is TDM?

- Activities that ensure people are aware of, understand and have access to the full range of travel options available in the region.
- Maximize and complement transportation investments





Metro's Regional Travel Options (RTO) Program

Provides grants and supports efforts that increase travel options use.

- Safe Routes to School




