Legislative Action Alert: Support Historic Funding for Safe Streets in HB 2025

The first draft of the package includes two historic wins for street safety:

- \$50 million per biennium for Safe Routes to School
- \$250 million per biennium for the new Great Streets Improvement Fund

HOW TO SUBMIT WRITTEN TESTIMONY

1. Prepare your testimony.
2. Go to the link at: <https://olis.oregonlegislature.gov/liz/2025R1/Testimony/JTR/HB/2025/0000-00-00-00-00?area=Measures>
3. Scroll down to the bottom of the page and find the "*Choose a meeting date*" dropdown box. Select the date (current date)
4. After selecting the date, more options will appear. There is only one bill to testify on, **HB 2025**.
5. Enter your information including *Name*, *Email*, *City* and *Organization* if applicable.
6. Next to the final box, "*Position on Measure*," select *Support*.
7. Scrolling down, you will see you can either directly enter the text of your testimony with the "*Text Testimony*" option or upload a pdf document of it if you select the "*Upload a PDF*" option.
