Take the survey to help weigh in on the future of N.E. Sandy Boulevard between N.E. 230th Avenue and N.E. 201st Avenue.

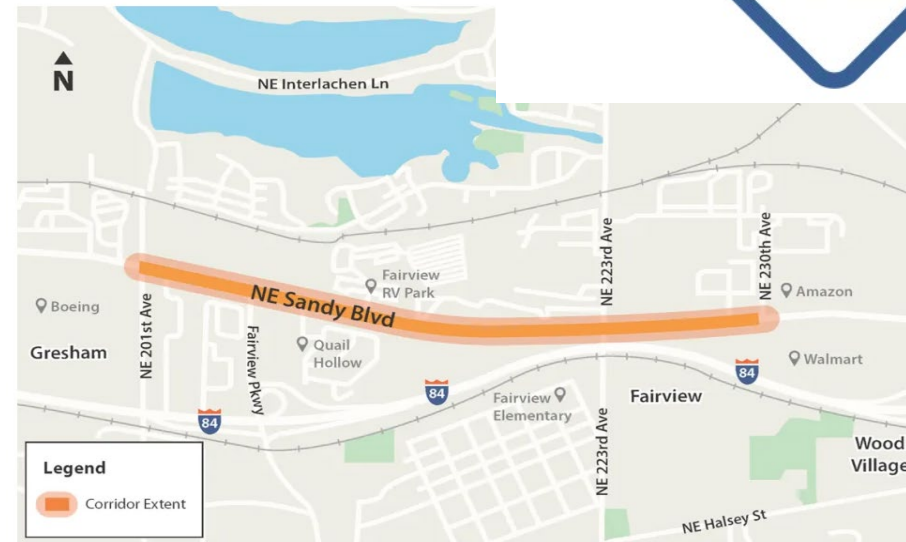
