**The Multnomah County Bicycle and Pedestrian Community Advisory Committee (BPCAC) Work Plan is a living document to provide opportunities to plan and focus for upcoming meetings. Proposed topics will be adjusted based on feedback. Some tentative agenda items are may shift dates to accommodate project and presenter schedules or emerging priorities.**

**BPCAC's [bylaws](#) provide guidelines for the purpose and duties of the Committee. These are:**

- 1. Advise the Board and the Transportation Division on matters involving bicycle and pedestrian transportation**
- 2. Identify specific bicycle and pedestrian issues, problems, and opportunities, and assist in evaluating projects for the Capital Improvement Plan\***
- 3. Serve as a source of volunteers for assisting the Transportation Division at public events supporting bicycle and pedestrian issues.**

**\*The Bicycle Capital Improvement Plan and the Pedestrian Capital Improvement Plan were folded into the 2020 Roads Capital Improvement Plan(CIP).**

**Multnomah County staff use the bylaws to guide the identification of topics, presentations, and updates to bring to the BPCAC along with feedback from committee members.**

**Through Metro, the [Safe Streets for All grant program](#) awarded funding that will enable our East County jurisdictions to develop a coordinated strategy for reducing fatal and serious injury traffic crashes. The TSAP development timeline is 2024-2025.**
