No Medicaid?

You might have some immediate options:

Family support

- \$1,418.12 annual limit for similar services in Community First Choice (next slide)
- Current restrictions to Family Support Funding:
 - If client is Title XIX (medicaid) eligible, they must access a Title XIX service (not SE150: which is both Family Support and SPPC).
 - All services must be immediately accessible at time of submission (i.e. PPL paperwork is complete, purchasing supplemental docs are submitted, etc.)
 - SE150 funding (Family Support & SPPC) are only available through 6/30/2022.
 - SC must check in with a PS prior to completing an ASP/ISP (prior to any submission) to ensure access to funding and/or proper documentation. I.e. PS permission to access SE150 is required before having a family sign any ASP/ISP.

Other funded supports

Lower level/intensity of care

Higher



Family Support

\$1418.12 annual support



State plan personal care

20 hours a month of attendant care



Children Intensive In-home Services

In home supports for intensive medical or behavioral needs, based on your assessment.



Foster care

24/7 support in a family home. 2-3 at most people in foster home.



Group home

Higher level of care, living in a neighborhood with other people run by an organization. 24/7 staffing, meals, supports. Very limited availability.

Has to be ODDS certified placement

Timeline

16 years old

17

17 and 1/2

18



Begin the transition age conversation with your service coordinator.



Begin making your plan



All plans and documents in place

Questions to consider:

Is your parent going to apply for guardianship?

Are you going to continue to live where you are or will you create a transition plan to live somewhere else in the community?

Are you going to continue with transition services through public school? If not, are you looking for employment?

Transitioning to adult services at 18

- ❑ Individual: Apply for adult Supplemental Security Income (SSI)
- ❑ ONA Assessor to complete a new ONA assessment.
Services Coordinator to complete ANA.
- ❑ Community Developmental Disability Program:
Determine adult IDD eligibility
