### **Tally and Explanation**

rev 6/22 ORS 254.529

- Deadline A county elections official may only begin the hand count after certification of the official results to the Secretary of State, but not later than the 27th day after the election. All hand counts must be completed no later than the 35th day after the election.
- → Complete a separate form for any precinct or batch where exceptions or differences between the original result and the hand count result were identified. Provide an explanation of any difference between the hand count and the tally of votes produced by the vote tally system, as determined by the counting board.
- If no exceptions or differences are identified by the counting board, the results for all precincts and batches may be summarized on a single form.
- Only one certification is required to be signed and returned with results.

#### **Explanation of Exceptions**

→ Valid votes that have been marked by the voter outside the vote targets or using a marking device that cannot be read by the vote tally system shall not be included in making the determination whether the voting system has met the standard of acceptable performance for any precinct or ballot batch under ORS 254.529(8)(a) through (c) and are to be listed as exceptions.

All 8 exceptions listed above occurred as a result of the tally room adjudication board and the hand count board making different determinations about whether or not something filled in on the write in line should be counted as a write in or an undervote. For example, this most frequently occurred when what was written on the write in line was the name of a fictional character and sometimes a phrase. I have listed the number of exceptions encountered in the corresponding boxes below.

AB-0291 - 3 exceptions

AB-0320 - 1 exception

AB-0353 - 1 exception

AB-0408 - 2 exceptions
