Our city should be governed by the citizens, not by the special interests of a select few. As a Portland native, I can appreciate the natural beauty and diverse population of our great city. I want to be part of a return to true citizen-led government, not indebted to any of the existing political machinery.

Being a single parent with two children in Portland Public schools, the budget debate took on a human side when my oldest son's teacher received her layoff notice this spring. The decision to run for this seat came from the realization that someone had to stand up and demand accountability as to how our tax dollars are being managed and spent. As a council member, I will do just that.

#### School Funding

I truly believe we can solve the current budget problems on a local level. The tax dollars are certainly there. It may just be a case of revamping the allocation of funds to focus more on teachers and class sizes. I am currently talking with members of local teachers unions to create a solution similar to the 95-5 measure California votes on this fall.

### Affordable Housing

As a realtor, I see first hand how Portland's affordability ranking has dropped dramatically. The April 1996 zoning revisions will help keep multi-family housing more affordable; however, single family home prices continue to soar. I support a gradual buffer zone around the Urban Growth Boundary to ease development, prevent urban sprawl, and keep homes more affordable.

#### Taxes

I see no reason to increase any taxes for the residents of our city. An effectively managed city council should have no problems allocating tax dollars to Education, Recycling, Community Policing, Sewage Overflow, and programs *you* consider important.
