


Community Services - OAA Transportation

- OAA-Older Americans Act
- Our culturally specific and neighborhood based senior center partners utilize OAA funding to provide transportation services to older adults through Trimet, Radio Cab, Ride Connection.
- These rides connect older adults to community activities such as social events, health promotion classes, and nutrition programs.
- Participants have the opportunity to maintain an enhanced quality of life outside the home and reduce social isolation

Community Services - OAA Transportation

The OAA Transportation Program has served a total of 440 clients this Fiscal Year 2025 (Year To Date) with an average of 280 clients per month

Providing a total of 3,105 service units (public transportation fares and cab rides) at an average of 345 service units per month

Radio Cab Ride Connection

TriMet

Of the 440 clients served 73% have accessed services provided by TriMet 28% Radio Cab

and 3% Ride Connection



Non Medical Transportation

In-home services option provided by regional contracted transportation providers or homecare workers (HCWs) and In-Home Care Agency (IHCA) caregivers

- TransDev-Transportation Brokerage
- Coordinates and schedules rides for **eligible Medicaid participants**
- Rides allow participants who cannot use public transportation the opportunity to access their community
- Local independent transportation providers offer services through a sedan or wheelchair van to accommodate both ambulatory and non-ambulatory individuals




Non Medical Transportation

Community Services - Transportation

Goals for the new 2025-2029 Area Plan:

- Multnomah County plans on exploring innovative options to expand the Non-Medical Transportation program to address unmet needs and constraints
- OPI-M (Oregon Project Independence Medicaid) consumers will eventually transition under the umbrella of non-medical transportation to receive services
- With the transition of these consumers, Multnomah County will work with State Programs and AAA's locally and nationally to explore other innovative options to address the high demand for services



Community Services - Transportation

Pilot Program

- Multnomah County will explore expanding transportation services through a potential partnership with Uber or Lyft
- These services are already available through the State of Oregon OHA "TNC Pilot Program"
- AAA's and Medicaid Agencies nationwide have partnered with Uber/Lyft to provide non medical transportation services
- The Pilot program will measured through ongoing data evaluation of costs, savings, ride availability, and consumer satisfaction
- The pilot program may expand to other ADVSD programs
