DUI Intensive Supervision Program

Eligibility

High Risk (Impaired Driver Assessment)

High Need (Substance Use Disorder)

Repeat DUI offenders:
No less than two and no more than seven prior DUI convictions, including diversion and pending charges

Goals

Promote public safety by working with repeat DUI offenders. Through intensive, collaborative supervision and effective treatment, DISP strives to reduce recidivism, change lives, and increase public safety

Support

Program addresses the needs of clients from CJC grant funding:

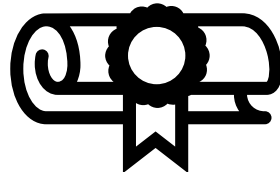
- Transportation

Eligibility

Uses the quadrant system that serves any combination risk and need

For those charged with Measure 11 Assault I, Assault II, Robbery I and Robbery II

Goals

Highly structured supervised probation for individuals charged with certain Measure 11 offenses for whom behavioral health treatment, rather than long-term incarceration, seems the best way to promote durable public safety

Support

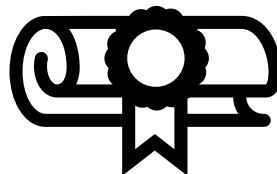
Level of services depends on an individual's assessed risk and need

Support

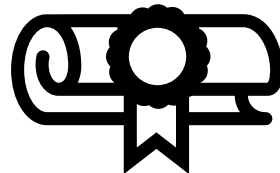
Provides treatment services,

Eligibility

High Risk/High Need

Primary diagnosis of a Serious Mental Illness, Schizophrenia Disorder, Schizoaffective Disorder, Bipolar I or II Disorder, Major Depressive Disorder, may have a co-occurring Substance Use Disorder, legally competent,

Goals

To ensure public safety and minimize recidivism while diverting defendants with a serious mental illness from incarceration and instead facilitating linkage to appropriate treatment and community resources

Support

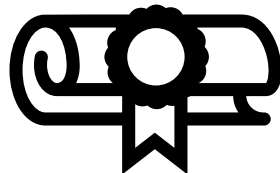
Help access housing, job opportunities, school, treatment (mental health services, drug and alcohol treatment and medical care)

Eligibility

High clinical need for substance use disorder and/or mental health treatment

Veteran that received an honorable or general under honorable discharge, eligible for VA healthcare

Goals

Enhance public safety, reduce crime, encourage accountability, provide substance abuse treatment and integrated mental health care, reduce costs to our community, and support individuals to make positive changes
