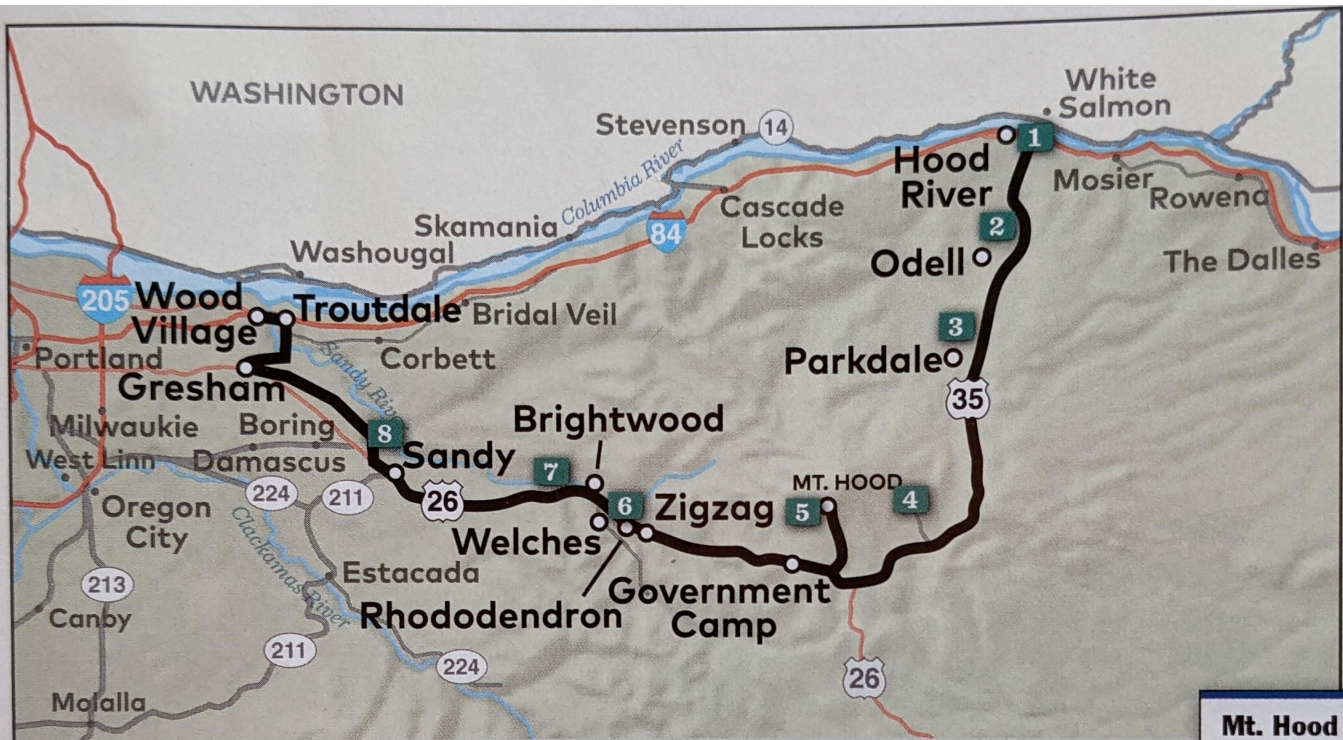

The removal of 433 trees along Dodge Park Blvd ROW Habitat along with many other East County Country Roads represents an adverse effect to scenic views as a natural resource.



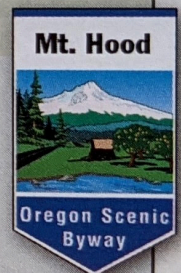
