Comments should be directed toward the approval criteria listed below and must be received prior to the close of the Hearing. The hearing procedure will follow the process outlined in Multnomah County Code 39.1140 (Hearings Process) which will be explained at the hearing.

Written testimony must be received by the Land Use Planning office by June 29, 2023 at 2 pm in order for a copy of it to be delivered to the Hearings Officer before the public hearing. You may also submit written testimony during the hearing up until the record is closed by the Hearings Officer. If submitting written testimony in person at the public hearing, please provide at least three copies of the document. Written testimony submitted after the above deadline while the record is open will be provided to the Hearings Officer at the end of the hearing. All written testimony in the record will be added to the Document Library as soon as Land Use Planning is able. The Hearings Officer may close the record at the end of the public hearing or set the record to close at a specific date and time at the hearing.

The Hearings Officer may announce a decision at the close of the Hearing or on a later date, or the Hearing may be continued to a time certain. Notice of the decision will be mailed to the applicant, subject property owners, any person who submitted written comment, requested the decision in writing or provided oral testimony at the Hearing. A decision by the Hearings Officer may be appealed to the Land Use Board of Appeals (LUBA) by the applicant or other participants at the hearing. An explanation of the requirements for filing an appeal will be included in the notice of decision.

Any issue that is intended to provide a basis for an appeal to the Land Use Board of Appeals (LUBA) must be raised prior the close of the public record. Issues must be raised and accompanied by statements or evidence sufficient to afford the County and all parties an opportunity to respond to the issue.

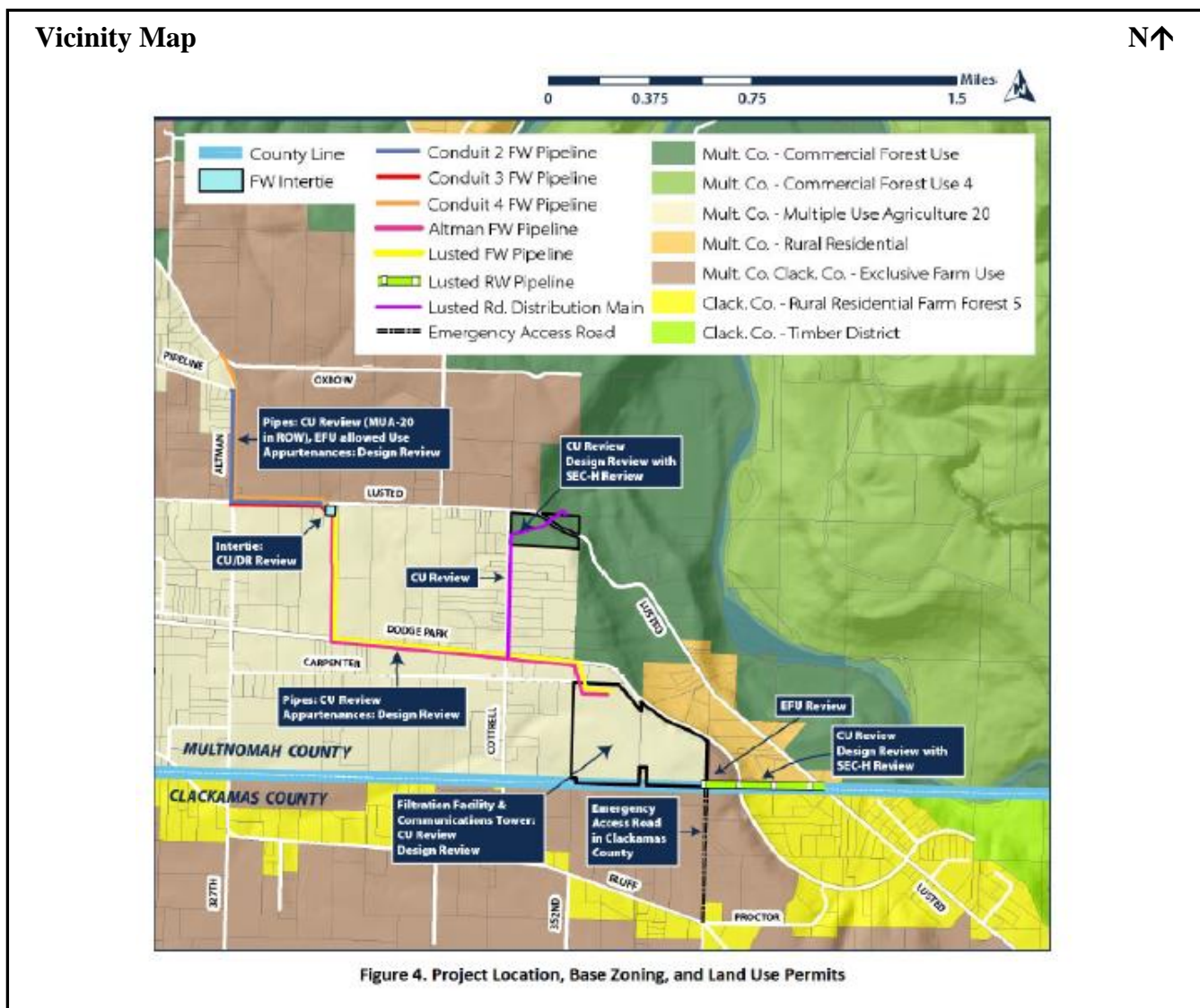
