Bianca Popescu: There are 8,474 injury crashes occurring in East Multnomah county during that time period. You can see here. This map is showing kind of the density of crash concentrations. The majority occurred along the arterial network.

Bianca Popescu: and also we found in the data that people walking, biking, and using a motorcycle were more likely to be involved in a serious injury or a fatal crash, which are the in this bar chart. The 3 columns at the end you can see the orange and the red are the fatal and serious injury crashes. The proportion is the highest for motorcycle than walking, and then bicycling.

Bianca Popescu: came to the top. So the 1st is speeding. We found that excessive speeds, especially in areas with speed. Limits of 30 miles, 35 miles per hour or higher, were the highest safety concerns.

Bianca Popescu: also intersections there there were a high incidence of bicycle, pedestrian and motorcycle crashes at intersections caused by vehicles failing to yield.

Bianca Popescu: we looked at crashes and the time of day, and also whether or not there was lighting at that crash, and we found that peak hours, especially the Pm peak hour and visibility.

Bianca Popescu: So the afternoon rush hour, especially in winter, when it's dark or dusk during the rush hour. That's where the most crashes occurred, and we also found that a lack of pedestrian scale lighting was a risk, safety concern as well.

Bianca Popescu: We also found impaired driving, so drug and alcohol use greatly increased the crash severity, especially at nighttime.
